Section 4: 'B' Sample Confirmatory Analysis Request Form	
<p>With regard to the 'B' Sample, the 'person(s) responsible' and the owner (if appropriate) may request that the 'B' Sample be sent for analysis by completing the Confirmatory Analysis Request Form (attached) and lodging it within the time period nominated on the form, otherwise the right to have the 'B' Sample analysed shall be deemed waived.</p>
